Solicitation for money or anything deemed inappropriate by the Childrens Parade Director onsite or the ABF in advance is strictly forbidden and will be enforced by removal from the Parade route if deemed necessary.
4. The Apple Blossom Festival will not be responsible for any injury or damages prior to, or during the Parade and the parents/guardians that participate do so on their own.
5. The Childrens Parade Director has complete authority over the Parade.
